The Vallarta Botanical Gardens, like many public gardens, was hard hit this year by the Covid-19 Pandemic and closures. In spring of 2020 closure was ordered by local government and the garden was closed to visitors for 75 days from April to June. Concurrently all staff were temporarily laid off and survival of the collections carried out by only a few masked and physically distanced staff. After the closure the garden reopened although tourism was negligible in the Puerto Vallarta region not only for that period but also for the rest of the fiscal year. During this time, the Gardens was fortunate to have the Friends of the Vallarta Botanical Gardens to provide support for the skeleton staff and critical operations of the garden. New development and improvement projects ceased as well as production of the Leaflet (newsletter) and closure of an office in PV.

The gardens reopened but in the summer months when visitacion is low due it being the rainy season with high humidity and temperatures. At the end of the Year operations were limited due to lack of entrance fees. The Gardens was very fortunate to receive aid from the Stanley Smith Horticultural Trust in a special bequest for support during Covid closure. Plant Conservation: Native Forest and its Biodiversity conservation Early in the year (before closure) was declared Year of the Animal to help promote the importance of native vegetation to the conservation of larger threatened creature like the Jaguar. Camera tracking and the addition of 20 new acres culminated in the Bird and Nature Festival just before shutdown.

Military macaws continue to increase their population to the delight of visitors and staff. A species threatened by illegal capture and sale. the species has shown that at least in a protected environment it can rebound.
